

# NEW CASTLE CITY POLICE DEPARTMENT 2020 ANNUAL REPORT





## Introduction

On behalf of the men and women of the New Castle City Police Department, it is my pleasure to submit our first annual year-end report. This report will serve as a summary of the New Castle City Police Department's initiatives, enforcement activities, and achievements.

# Summary

By any measure, 2020 was a challenging and tumultuous year. Police operations were affected by both the global pandemic and civil unrest and yet, despite the many distractions, the men and women of the New Castle City Police Department continued to uphold their oath and serve the residents, the visitors and those who work in the city.

The way the police department responded to calls for service looked different during 2020 and continues to look different as we attempt to limit exposure of COVID 19 infections to officers. However, officers continue to patrol regularly, take action when necessary and investigate criminal conduct. A detailed crime analysis report is included in this report.

NCPD entered 2020 with several significant initiatives. Many were forced to be placed on hold because of the COVID 19 restrictions. However, NCPD was successful in completing a few projects that have been identified as initiatives necessary to help gain community confidence. Those initiatives are outlined in this report.

# **Initiatives**

The most important initiative was our goal to achieve accreditation. Accreditation was met after an independent group of assessors evaluated our agency's policies and procedures to ensure consistency and compliance with police operations, training, and administrative effectiveness.

For the community, accreditation increases the law enforcement agency's ability to prevent and control crime through more effective and efficient delivery of law enforcement services. Accreditation enhances community understanding of the law enforcement agency and its role in the community as well as its goals and objectives. Citizen confidence in the policies and practices of the agency is increased.

After several years of redevelopment that included significant changes to command structure, patrol structure and administrative procedures, NCPD began the evaluation

process. In September of 2020, NCPD was awarded Accreditation by the Delaware Police Accreditation Commission (DPAC).



Shortly after receiving accreditation, NCPD applied to have our Response to Resistance Policy (Use of Force) certified by a federally approved agency. The purpose behind the process was to certify that our department met certain eligibility requirements set forth by the U.S. Department of Justice. Pursuant to Section 2 of the Presidential Executive Order on Safe Policing and for Safe Communities, U.S. DOJ discretionary grant funding is only available to agencies who meet the standards.

The President's Order requires agencies to meet two standards in order to be successfully certified: 1) that the agency's use of force policies prohibit chokeholds, except in situations where the use of deadly force is allowed by law; and 2) that the agency's use of force policies adhere to all applicable federal, state, and local laws. The order also outlined twelve discretionary standards that addressed additional use of force standards along with community engagement programs. NCPD met all fourteen (14) of the standards.

On December 18<sup>th</sup>, 2020, the Delaware Police Accreditation Commission certified our Response to Resistance Policy.

Another initiative was to continue our commitment to become more transparent and to connect with the community through several outreach platforms. Our Facebook page established in the summer of 2018 continues to attract new followers. In early 2020 we set out to establish a stand-alone website. The goal of the website was to provide visitors with a more in depth look at the structure, the mission and the day-to-day operations of the police department. The site was also designed to serve as a tool for visitors to get answers to frequently asked questions or provide a link to a site that may help them address a variety of concerns. The site, newcastlecitypolice.com, successfully launched in December of 2020.

In an effort to provide local businesses and residents with additional methods to protect their valuables, NCPD partnered with Protech DNA. NCPD is now providing free DNA kits for residents. The kits come with a tool that allows residents to swab their property with an adhesive that has unique micro dots embedded and can be identified using a special reader provided to the police department.

This program provides police with a tool to identify property that has been recovered and return it to the its owner.

# **Community Engagement Programs**

Many of the traditional community engagement programs our department has been involved with were either altered or canceled as a result of the COVID restrictions. However, we were successful in establishing a few new community relationships and continue (in some form) a few of the more treasured programs.

In August we welcomed Pastor Phyllis and some members from Christ Embassy Church. They visited with our officers and staff during a time when protests and unrest took center stage. They visited to join us with a meal they provided, share fellowship and to remind us that there are members of the community who support police.







The annual Christmas for Kids party hosted by the Goodwill Fire Company was canceled, but organizers found a way to provide for local families. Thanks to the tremendous support of our community, the Trustees of the Common, members of Goodwill Fire Company and The New Castle City Police Department, four families were provided with gifts for the children in their households.









For several years, NCPD has been awarding Citizenship Awards to school age children at Carrie Downie Elementary. The recipients are selected by teachers after showing a consistent pattern of good conduct in and out of the classroom. It has become a popular award that children strive for, promoting good behavior. We managed to issue a few awards before schools closed and we look forward to returning in the fall of 2021.





As a result of gathering restrictions, one very popular community event was canceled. For the last few years NCPD and the Goodwill Fire Department hosted a backpack drive. Once again, through the generosity of residents, local businesses and the Trust, backpacks and school supplies were collected and distributed so that our children could start school properly equipped. We look forward to hosting this event before the start of the 2021-2022 school year!









In 2020, The New Castle City Police Department joined many other law enforcement agencies in Delaware to participate in Take Care Delaware. A recent national survey revealed that approximately 60% of American children have been exposed to violence. TCD provides officers who identify children exposed to violence and trauma, an avenue to send a confidential note to the child's school. No details are released, just a note that says "Take care of Johnny".

NCPD went a step further and started a program where officers would provide children at the scene of a traumatic event with teddy bears. Once again, local residents, businesses and community leaders answered the call and donated dozens and dozens of bears.



It's hard to imagine that the global impact of COVID 19 spared anyone. That includes all of our high school seniors who missed out on traditional graduation ceremonies. Local residents and educators came up with new and creative ways to recognize these students. The New Castle City Police Department was thrilled to join the Goodwill Fire Company and Bob Kelly of FOX Philadelphia's Good Day, along with educators from William Penn High School as they traveled from house to house to pay tribute to local seniors. 
# Staffing/Structure

NCPD entered 2020 with fourteen (14) officers in service and a civilian police administrative assistant. Three (03) recruits began the year in the New Castle County Police Academy. All three recruits successfully completed the six-month training program and graduated in March of 2020. COVID restrictions prevented the recruits from experiencing a time-honored ceremony, but NCPD hosted a small celebration with the families of the graduates.





Upon the completion of a revamped and extensive Field Training Program, the recruits joined the ranks of NCPD and our staffing increased to seventeen (17) sworn officers with a civilian Police Administrative Assistant. The organization chart below illustrates the current structure of our department.



# Achievements

In 2020, NCPD continued to promote advanced training for officers that have expressed interest and demonstrated proficiency in becoming certified in critical areas that typically require us to outsource the service.

NCPD recognized an increase in drug related DUI incidents. In order to properly prosecute a drug related DUI, a highly trained Drug Recognition Expert (DRE) is used to perform an extensive battery of tests that range from traditional field sobriety tests to more complicated assessments to include recording vital signs. There are only a few DRE certified officers in Delaware.

In November of 2020, after weeks of classroom and field training, Sergeant Richard Perillo was certified as a DRE. In just a few short months, Sergeant Perillo has been called on by agencies across the state and within the city of New Castle to assist in prosecuting DUI cases.





During the same time frame, Sergeant Perillo received his National EMT Certification. "The National Registry's mission is to provide a valid, uniform process to assess the knowledge and skills required for competent practice by EMS professionals throughout their careers, and to maintain a registry of certification status."



NCPD continues its commitment to train our officers in the recognition, awareness and treatment options related to mental health and substance abuse. We continue to work with other agencies and non-profit organizations to keep our officers informed on the latest programs and provide up to date training so that we can better serve those affected by these diseases.

As part of that commitment, Captain Tina Shughart continues her work with the Veteran Response Team (VRT), Crisis Intervention Team (CIT), and Crisis Response Team (CRT). In addition to her association with these teams, Captain Shughart was recently certified by the National Council for Behavioral Health in providing "Mental Health First Aid", to those who suffer from mental health or substance abuse challenges.







# **Enforcement**

Enforcement remains an integral part of policing. However, in the midst of a global pandemic, civil unrest and criminal justice reformation, police officers are experiencing unprecedented challenges. While other jurisdictions have seen an increase in violence, New Castle City has seen a decline. It should be noted that some of the decrease in enforcement stems from mitigation policies that have slowed self-initiated policing. Despite the distractions, NCPD continues to promote safety through high visibility patrols

The following graph provides a general view into the department's enforcement activity between 2016 and 2020. The data is broken down to reflect the number of traffic summons issued, and arrests made by category.




The graph below illustrates all the calls for service that are typically initiated by an individual requesting police service. Most calls are initiated through the Regional Communications Center (RECOM) via 911 or the non-emergency number. These statistics do not include calls that are initiated by the officer, such as traffic stops.




The next graph is a summary comparison of crimes initiated against a person. Some typical crimes that would constitute a crime against a person are assaults, robbery, terroristic threatening, etc.




The following graph depicts the number of gun violations and shootings our officers responded to. The cases labeled unfounded are incidents where our officers responded to the call of a shots fired/shooting and no evidence was located to corroborate the call. The cases labeled shooting involve incidents where ballistic evidence was recovered indicating a firearm was discharged, or the identification of a person or property having been struck.




Property crimes consist of burglaries, thefts, thefts from and of vehicles, shopliftings, criminal mischief, etc.




Domestic calls are incidents that involve intrafamilial matters or incidents involving people in intimate relationships. Not all domestic calls lead to arrests or involve criminal conduct. However, all domestic calls are required to be documented.




The graph below illustrates all the calls the police department respond to involving incidents related to a mental health crisis, first aid/CPR, check on the welfare, etc.



NCPD officers continue to follow the compassionate response policy that began in late 2016. NCPD has also hosted several community programs where our instructor trained the public in the use of NARCAN and provided the attendees with NARCAN provided by the non-profit group Attack Addiction. NCPD has committed to share all of overdose data with a non-profit group Overdose Data to Action Grant for analysis.







Title 11, Section 4120 and 4121 of the Delaware Code, known as Megan's Law, requires the Delaware State Police to maintain a registry of sex offenders. A link to that registry can be found on our website. (newcastlecitypolice.com). Offenders convicted of specified sex offenses are required to register and in specific cases, local jurisdictions are required to make notifications. The graph below illustrates how many notifications NCPD has done.




The following graph is a summary of all the calls involving alarms. They include hold up (robbery) alarms, burglar alarms, vehicle alarms, etc.



The following graph is a summary of DUI arrests made between 2016-2020.




The crash data illustrated in the next few pages, is a breakdown of all crashes NCPD responded to. Not all crashes require reports. For example, most crashes that occur on private property do not require a report unless certain conditions exist, i.e., serious injury, DUI, structural damage, reckless driving. We are still dispatched to determine if any of those conditions exist. In some cases, we are needed to help facilitate an information exchange.











When conducting a crash investigation that requires a report, officers are provided with a list of primary contributing factors the led to the crash. In other words, the cause of the crash. The following few charts identify the top six or seven leading primary contributing factors between 2016-2020.











Response time is measured from when a call is made to the dispatch center to when an officer arrives on scene. There are many factors that affect response time such as staffing, complaint load, traffic, and delay in dispatching to name a few. Outliers, such as a priority one complaint being downgraded can also affect the overall average. For example, if an officer was dispatched to a stabbing, that would typically be a priority one call for service. But, if the stabbing was determined to be late reported, the victim was not at the scene of the incident and the officer does not have a location to call out on, the time could be skewed.

The following charts identify some examples of the calls categorized as priorities One, Two, Three and Five.




